

# Privacy Policy

This privacy policy applies between you, the User of this Website and MNH Sustainable Cabin Services, the owner and provider of this Website. MNH Sustainable Cabin Services takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

## Definitions and interpretation

1. In this privacy policy, the following definitions are used:

<b>Data</b>	<b>Collectively all information that you submit to MNH Sustainable Cabin Services via the Website. This definition incorporates, where applicable, the definitions provided in the General Data Protection Regulation (EU 2016/679) (GDPR);</b>
<b>Cookies</b>	A small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below ( <b>Cookies</b> );
<b>MNH Sustainable Cabin Services Limited, we or us</b>	MNH Sustainable Cabin Services Limited, a company incorporated in England and Wales with registered number 22 whose registered office is at Rowfant Business Park, Wallage Lane, West Sussex, RH10 4NQ;
<b>UK and EU Cookie Law</b>	The Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
<b>User or you</b>	Any third party that accesses the Website and is not either (i) employed by MNH Sustainable Cabin Services and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to MNH Sustainable Cabin Services and accessing the Website in connection with the provision of such services; and

  - b. References to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. A reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. Reference to any statutory provision includes any modifications or amendment of it;
  - f. The headings and sub-headings do not form part of the privacy policy

## Scope of this privacy policy

3. This privacy policy applies only to the actions of MNH Sustainable Cabin Services and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

## Data Collected

4. We may collect the following Data, which includes personal Data, from you;
  - a. Demographic information such as post code, preferences and interests;
  - b. IP address (automatically collected);
  - c. Web browser type and version (automatically collected);
  - d. Operating system (automatically collected);In each case, in accordance with this privacy policy.

## Our use of Data

5. For purposes of the General Data Protection Regulation (EU 2016/679) (GDPR), MNH Sustainable Cabin Services is the “data controller”.
6. We will retain any Data you submit for 12 months.
7. Unless we are obliged or permitted by law to do so, and subject to any third party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and / or other companies with our group.
8. All personal Data is stored securely in accordance with the principles of the General Data Protection Regulation (EU 2016/679) (GDPR). For more details on security see the clause below (**Security**).
9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
  - a. Internal record keeping;
  - b. Improvement of our products/ services;
  - c. Contact for market research purposes which may be done using email, telephone, fax or mail. Such information may be used to customise or update the Website;In each case, in accordance with this privacy policy.

## Third party websites and services

## **Changes of business ownership and control**

Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
13. We may also disclose Data to a prospective purchaser of our business or any part of it.
14. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

## **Controlling use of your Data**

15. Wherever you are required to submit Data, you will be given options to restrict our use of that Data. This may include the following:
16. Use of Data for direct marketing purposes; and
17. Sharing Data with third parties

## **Functionality of the Website**

24. All Cookies used by this Website are used in accordance with current UK and EU Cookie Law.
25. Before the Website places Cookies on your computer, you will be presented with a message bar requesting your consent to set those Cookies. By giving your consent to the placing of Cookies, you are enabling MNH Sustainable Cabin Services to provide a better experience and service to you. You may, if you wish, deny consent to the placing of Cookies; however certain features of the Website may not function fully or as intended.

26. This Website may place the following Cookies:

Type of Cookie	Purpose
Analytical/performance cookies	They allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example by ensuring that users are finding what they are looking for easily.

**General**

- 30. You may not transfer any of your rights under this privacy policy to any other person. We may transfer our rights under this privacy policy where we reasonable believe your rights will not be affected.
- 31. If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 32. Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 33. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.

- 34. MNH Sustainable Cabin Services Limited reserves the right to change this privacy policy as we may deem necessary from time to time or as may be required by law. Any changes will be immediately posted on the Website and you are deemed to have accepted the terms of the privacy policy on your first use of the Website following the alterations.
